# Personal Information Collection Statements – Newspaper Subscriber

1. **Purpose of Collection:** China Daily Hong Kong Limited and China Daily Asia Pacific Limited (The "Companies") will collect your personal data for the following purposes:
  - processing of the subscription for our services and termination thereof;
  - incorporating into our user database of China Daily Hong Kong Edition or China Daily Global Edition;
  - handling of service calls, enquiries and complaints;
  - the daily operation for provision of our services;
  - conducting service surveys;
  - billing and collecting payment;
  - distribution of news alert and newsletter;
  - to promote or direct marketing of the latest offers and privileges from China Daily Hong Kong Edition or Global Edition, websites, services, seminars, events of the Companies, including subscription renewal offer, gifts, online shopping and other privileges;
  - to make disclosure as required under any law binding on the Companies;
  - auditing; and
  - other related purposes
  
2. **Data Collection:** In order for the Companies to provide services to our Subscribers, it is necessary for our Subscribers to supply us with personal data during the registration or subscription process. Personal data collected by us includes but is not limited to the following:
  - Name;
  - Contact address;
  - Telephone, mobile number and/or fax number;
  - e-mail address;
  - Payment record;
  - Bank account number and account holder name;
  - Credit card number, name of bank and expiry date; and
  - Other relevant data

You may decline to provide us with the requested personal data, but in such case, we may not be able to provide services to you. By submitting your personal data, you consent to the use of that data as set out in this statement and our Privacy Policy.
  
3. **Transfer of Personal Data:** Your personal data held by the Companies will be kept confidential but the Companies may provide such information to :
  - banks in connection with payment of relevant fees;
  - any professional personnel, agent, adviser, auditor, contractor or service provider who provides services or advice to us in connection with our operations including delivery agent;
  - any person or corporation under a duty of confidentiality to us;
  - person to whom we are required to make disclosure under applicable laws, governmental or regulatory requirements or pursuant to any order of a court of a competent jurisdiction; and
  
4. **Use of Personal Data for Direct Marketing:** The Companies may from time to time post or deliver to you direct marketing materials mentioned in Clause 1 based on your personal data provided to us. If you do not want to receive those direct marketing materials, please advise us by writing or by e-mail, or selecting the appropriate option under our newspaper subscription form.
  
5. **Personal Data Access:** Under and in accordance with the terms of the Personal Data (Privacy) Ordinance (Except where there is an exemption provided), you have the right to:-
  - check whether the Companies holds data about you and seek access to such data; and
  - require the Companies to correct any data relating to you which is inaccurate.

However, under normal circumstances, data will be erased after fulfilling the purposes of collection.  
The Companies may charge a reasonable fee for the processing of any data access request.
